The campaign

Every 3.5 minutes someone dies in the EU as a result of a workplace accident or work-related illness. The European Agency for Safety and Health at Work (EU-OSHA) aims to cut this death rate by improving safety and health across Europe. The campaign *'Working together for risk prevention'* forms part of Europe's ongoing Healthy Workplaces Campaign, which has helped drive significant improvements in workplace safety and health across the EU and beyond.

Although management and the organisations they lead are primarily responsible for safety and health, the most effective results are always obtained if they actively engage with their workforce and their representatives. For this reason, the campaign has two main elements.

Firstly, it **encourages managers to show leadership in safety and health** by genuinely consulting with their workforce and by following the best available risk prevention strategies.

Secondly, it encourages workers and their representatives to share ideas and to actively work with their managers to improve safety and health for all.

Who can take part?

The Healthy Workplaces Campaign is open to all organisations and individuals at local, national and European levels, including:

- all employers in the public and private sector;
- · managers, supervisors, and workers;
- · trade unions and safety representatives;
- all organisations and individuals dedicated to improving safety and health.

How can you get involved?

You can get involved in the Healthy Workplaces Campaign 2012-13 by:

- disseminating and publicising campaign information and materials to raise awareness of occupational safety and health, within both your own organisation and those you work with.
