Proactive in keeping the dossier compliant with REACH

- Understands the registrant's responsibility to ensure safe use
- Follows ECHA guidance in preparing the dossier
- Reads the recommendations in ECHA's evaluation progress report every year







Proactive in keeping the dossier compliant with **REACH**

- Enjoys the edge offered by ECHA webinars
 - ECHA's compliance check priorities
 - Correct way of reporting study results





Proactive in keeping the dossier compliant with **REACH**

- **Spontaneously** update dossiers
- Able to plan own schedule of work
- Less likely to receive draft decisions





Thinks that the dossier is compliant forever

- Wrongly assumes that no update is needed after receiving the registration number
- Did not allocate resource for update of dossiers





Waiting for a draft decision?

- More likely to receive draft decisions under compliance check
- Needs to react quickly in formal decision-making process under REACH (30-day commenting period)





Needs to run to avoid a decision

- ECHA helps with:
 - Draft decision, pointing out how to improve for compliance
 - Informal communication may be offered in complicated cases
- If they react appropriately, it is still possible to avoid a decision

Update the dossier proactively: why?

- Good quality, up-to-date information on the substance is needed to ensure the safe use of chemicals
- REACH places the responsibility on manufacturers/importers to ensure safe use of their substances
 - Article 22 REACH: "Following registration, a registrant shall be responsible on his **own initiative** for updating his registration without undue delay with relevant new information ..."



Update the dossier proactively: how?

- The registrants have to provide adequate information on their registered substances
- Evaluation is here to help registrants do that
 - The annual evaluation reports may be considered ECHA's reminders
 - If we check and find non-compliance: (draft) decision ... to ask for improvement





Targeted compliance checks to improve dossier quality



Targeted compliance checks

- Aimed at having maximum impact on safe use of chemicals
- ECHA will target compliance checks to specific dossier issues where safety matters





Targeted compliance checks to improve dossier quality

- ECHA scientists check dossiers more efficiently with data-mining tools
- Poor entries will be caught
- Complements other compliance check activities
- Most efficient use of ECHA evaluation resources

High quality information is required for REACH compliance

Recommendations on how to fulfil these REACH requirements:

- Identifying your substance clearly
- Making sure test material is representative
- Making intelligent use of all available information
- Providing clear use and exposure information

Follow-up of dossier evaluation decisions

After the deadline in the decision, ECHA looks at the latest dossier.



Requests not fulfilled: ECHA notifies Member States of noncompliance. May lead to enforcement. New information leads to further concerns: another compliance check.

Requests fulfilled: ECHA notifies Commission and Member States.
